

AMENDMENT TO THE CITY MANAGER CONTRACT BETWEEN THE CITY OF MANTECA AND TONI LUNDGREN

This Amendment ("Amendment") to the contract between the City of Manteca and Toni Lundgren is made and entered into this 18th day of June, 2024 by and between Toni Lundgren ("Lundgren") and the City of Manteca, a municipal corporation, by and through the City Council ("City") (together the "Parties").

RECITALS

A. WHEREAS, effective July 1, 2023, the City of Manteca entered into a contract for Lundgren to serve as City Manager (the "Contract");

B. WHEREAS, Section 14 of the Contract allows the Parties to mutually agree to amend the Contract in writing;

C. WHEREAS, the City desires to amend the Contract between the City and Lundgren.

NOW, THEREFORE, the Parties hereby agree as follows:

1. Section 3(a) of the Contract is hereby amended to read as follows:

"LUNDGREN'S compensation shall increased by six percent (two percent cost of living plus a four percent merit) to \$270,300 annually, with an effective date of July 1, 2024.

LUNDGREN'S compensation shall be increased by three percent (cost of living) to \$278,409 annually, with an effective date of July 1, 2025.

LUNDGREN'S compensation shall be increased by three percent (cost of living) \$286,761 annually, with an effective date of July 1, 2026."

2. Section 3(e) of the Contract is hereby amended to read as follows:

"CITY shall provide LUNDGREN a car stipend of \$500/month."

3. In the "Benefits" for LUNDGREN, the following adjustments and additions shall be made:

Administrative Leave

Increase annual hours received from 120 to 140; increase the cap of administrative leave from 300 hours to 320 hours; and increase the annual cash out amount from 80 hours to 120 hours.

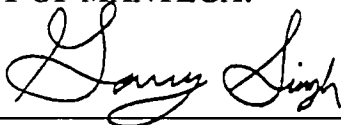
Wellness Benefit

4. Except as otherwise provided in this Amendment, the Contract shall continue in full force and effect.

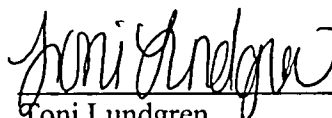

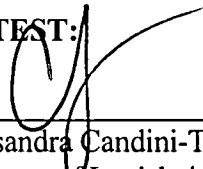

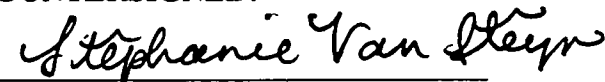
